

Privacy Policy

By submitting your personal data and using the Site, you consent to the processing of your personal data in accordance with this Privacy Policy.

1. Terms and definitions

1.1. Terms defined in our "Terms of Use" shall have the same meaning in this Privacy Policy, except where expressly stated otherwise.

2. Personal data collection

2.1. When registering on the Site, you create an Easybizzi Account. In order to create an Easybizzi Account, you must specify the following information:

- Your e-mail address, which will be the user name of your Easybizzi Account;
- A password that will be used to access to your Easybizzi Account.

2.2. Information about the name of your email (in the format abc***@email.com) which you specified when creating an Easybizzi Account will be partially available to Users.

2.3. You may place your photo on your Easybizzi Account profile and this will be publicly available to other Community Members.

3. Purpose of collection and use of personal data

3.1. Your personal data is collected with the purpose of notifying you about activities within the Community, as well as details of new materials that have appeared in any Community Educational Program that you purchased, as well as information on the transactions carried out in relation to your Easybizzi Account by e-mail.

4. Personal data protection

4.1. Each User independently and all Users jointly undertake and will take all necessary organizational and technical measures in order to protect personal data from manipulation, loss and destruction, as well as from unauthorized processing.

4.2. Any access to your personal data is protected by a password that you create when opening the Easybizzi Account.

5. Cookies

5.1. The Site uses cookies or similar technologies in order to collect certain information about the use of the Site when you access, view and use the Site.

5.2. You may prevent cookies from being used through the browser settings on your device. If you disable the use of cookies, some of the functions of the Site may not operate properly.

6. Your Rights

6.1. You may:

- 6.1.1. be provided of information from the Technical Support Service about your personal data, after confirmation of your ownership of an Easybizzi Account;
 - 6.1.2. access to your personal data in your Easybizzi Account;
 - 6.1.3. change your personal data in the case when your personal data are incomplete, outdated or inaccurate.
- 6.2. You have the right to delete Content that you have downloaded, as well as to terminate membership in the Community at any time and contact the Technical Support Service with a request to close your Easybizzi Account. When deleting your Easybizzi Account, all data contained in the Easybizzi Account is deleted from the Site within 72 hours and will be irretrievable after this time.
- 6.3. The Technical Support Service may retain your personal data after termination of your membership and removal of your Easybizzi Account, in order to comply with the requirements of applicable law.

7. Transmission of your data to third parties

- 7.1. Access to your personal data is provided to the Technical Support Service, which provides technical support services to the Site. Technical Support Service shall comply with the confidentiality transmitted and accessed, including not to transfer it to third parties, except for the cases specified in this Privacy Policy.
- 7.2. The Technical Support Service may transfer your data to regulatory or other state authorities and other third parties if this is required by law or reasonably necessary to protect the rights and to ensure the safety of any person.

8. Changes to this Privacy Policy

- 8.1. This Privacy Policy may be varied at any time.
- 8.2. You will be notified of changes to this Privacy Policy before continuing to use the Site.
- 8.3. If you continue to use the Site after receiving notice of changes to this Privacy Policy, you are deemed to have accepted the changes.

9. General legal conditions

- 9.1. If a court competent to consider such a matter, decides that any provision hereof is void, such provision shall be excluded from this Privacy Policy without affecting the operation of the remaining provisions. At the same time, the remaining provisions shall remain in force.
